

**GUEST RELEASE, WAIVER AND INDEMNIFICATION OF OAK PARK SPORTSMEN'S CLUB**  
**(For Parents or Guardians of Minors)**

IN CONSIDERATION OF being allowed access onto the premises of THE OAK PARK SPORTSMEN'S CLUB, INC., an Illinois Not-For-Profit Corporation (herein the "CLUB"), located at 14732 South Frontage Road, Plainfield, Illinois (herein the "PROPERTY") and/or use of the CLUB'S facilities the undersigned as parent or guardian (herein "PARENT") of the minor whose name appears below as "Guest" (herein the "GUEST") does hereby, on behalf of the GUEST, waive and release the Club from any and all claims by him/her for personal injuries and/or damage to his/her property. Further, the PARENT of the GUEST agrees to indemnify the Club against any and all claims for personal injuries sustained by GUEST or for damage incurred to GUEST'S property and to hold the CLUB harmless and defend it against any and all claims by GUEST because of injuries to GUEST or damage to his/her property while on the CLUB'S PROPERTY whether such injury or damage results from any condition of the PROPERTY or of the facilities located on the PROPERTY and whether such injury or property damage is caused by or results from any act or failure to act by GUEST or by any third party including but not limited to members of the CLUB, persons who are GUESTS of CLUB members, CLUB contractors, their employees or subcontractors or persons who are trespassers on the PROPERTY. This waiver, release and promise to indemnify and hold harmless shall be binding on the GUEST'S heirs, executor, administrator and assigns and shall inure to the benefit of the CLUB'S officers, directors and members and will expressly extend to all persons rendering first aid, assistance or personal care to the GUEST on the CLUB'S PROPERTY. The PARENT of the GUEST agrees to pay the CLUB'S reasonable attorneys' fees and all costs of litigation incurred by CLUB to defend against such claims or enforce its' rights under this RELEASE.

The PARENT of the GUEST acknowledges that he/she has read and understands this RELEASE and agrees to its terms and conditions and further understands that the RELEASE is a legally binding and enforceable contract between the CLUB and PARENT of the GUEST and also the GUEST as a consequence of which the PARENT of the GUEST and the GUEST are giving up certain legal rights in consideration of being permitted access to the CLUB'S PROPERTY. This RELEASE will continue in full force and legal effect until revoked in writing by the CLUB and delivered to the GUEST.

The PARENT of the GUEST hereby certifies that he/she is 21 years of age and that both PARENT of the GUEST and the GUEST have read and understood the CLUB'S *Club Safety Rules* as published and posted from time to time on its property.
